Page indentation: above - 20 mm, below – 20 mm, left – 25 mm, right –10mm.

2. Text formatting:

Title: Font: Times New roman; Size 12; Font style: Bold; Effects: All Caps; Paragraph Alignment: Centered.

Names of the author/s: typed under the title

at 1 line spacing – Name, abbreviated middlename (initials) and full Family name; Font: Times New Roman; Size: 12; Font style: Bold; Paragraph Alignment: Left
First line indent 10 mm. University degrees and titles are not included.

Address/s for correspondence: Skip a line and use NO abbreviations, Font: Times New Roman; Size 12; Font style: Effects: All Caps; Paragraph Alignment Justified, First line indent 10 mm.

The Abstract and key words are in one of the conference official languages (Bulgarian, English, and Russian) in the following format:

ABSTRACT up to 10 lines, skip 1 line; Font: Times New Roman; Size 10; Font style: Italic; Paragraph Alignment: Justified.

KEY WORDS – skip 1 line; Font: Times New Roman; Size: 10; Font style: Italic; Paragraph.

References are given as endnotes.
